Availability

Issue Age:

Based on product minimum and maximum ages.

Benefit Amount

The rider provides a one-time lump sum accumulation value (AV) credit. This AV credit is calculated as 3 times the greater of the minimum monthly premium or the minimum guaranteed premium (if applicable). This amount is set at issue. After issue, changes do not impact the benefit amount.

Qualifying Event

The benefit amount is credited when we receive a completed form and satisfactory proof from a physician they have provided reproductive assistance of a qualifying event covered under this rider while the policy and this rider are in force. Qualifying events:

- **Artificial insemination:** The procedure where washed and concentrated sperm has been placed directly into a uterus, which is also known as intrauterine insemination (IUI).
- **Assisted reproductive technology (ART):** Any fertility-related treatments in which eggs or embryos are manipulated, including but not limited to in vitro fertilization (IVF).
- **Surgery:** Operative laparoscopy and hysteroscopy procedures for the explicit purpose of fertility assistance.

The rider excludes procedures in which ovarian stimulation is performed without a plan for egg retrieval.

Charges

This is a no-additional cost rider automatically added to all new eligible policies, depending on state approval.

Waiting Period

The period between issue of policy and when the qualifying event can occur for the insured to be eligible for benefits.

This new rider has a waiting period of two years from the issue date.
